

## **SELPHY – PHOTO ALBUM PROMOTION TERMS & CONDITIONS**

### **1. PARTICIPANT**

- 1.1. Participants must be resident in the European Union.
- 1.2. All participants are deemed to have agreed to be bound by these terms and conditions.
- 1.3. This promotion is only available on any purchase of the SELPHY ES1, ES2, ES20, ES3, ES30, CP740, CP750, CP760, CP770 in the UK or the Republic of Ireland, excluding purchases made with a camera in the same box.
- 1.4. Employees of Canon (UK) Ltd (“Canon”), its subsidiary companies, their families, agents and other parties directly involved with this promotion are not eligible to enter.

### **2. HOW TO PARTICIPATE**

- 2.1. This promotion is for an A5 wooden photo album
- 2.2. To enter the promotion, the participant must purchase any of the qualifying models (listed above in 1.3) from a retailer in the UK or the Republic of Ireland during the promotional period specified in Clause 2.3 below.
- 2.3. Purchases must be made between Saturday 1 November 2008 and Wednesday 31 December 2008 to take advantage of this promotion. Purchases made after 31 December 2008 will not be eligible for the promotion
- 2.4. In order to claim the album, participants must submit a claim as follows:
  - 2.4.1. Fully and correctly complete a claim form that can be obtained either in-store, downloaded from [www.canon.co.uk/selphyalbums](http://www.canon.co.uk/selphyalbums) or [www.canon.ie/selphyalbums](http://www.canon.ie/selphyalbums) or obtained by contacting the promoter.
  - 2.4.2. Send the completed claim form, together with a photocopy of the original receipt or valid proof of purchase to “Canon SELPHY Album Promotion, Freepost RRZH-TBLE-GCUE, Hope Road, BRISTOL, BS3 3NZ” to be received before midnight 31 January 2009.
  - 2.4.3. Where availability permits a choice of design, Canon will endeavour to send out the designated first choice of album design. If the first choice is not available at the time the claim is processed the second choice design will be sent and if the second choice design is unavailable, the third choice design will sent
  - 2.4.4. Participants must clearly state clearly on the claim form the order of preference for the 3 available album designs in the dedicated area of the form. Where no preference is shown on the claim form, Canon will provide the Participant with the album design with the most availability at the time the claim is processed. Choice of design is strictly subject to availability.
- 2.5. The deadline for receipt of all claims by Canon is midnight 31 January 2009. Canon accepts no responsibility for claims not received by this date and any claim received after this date will not be processed.
- 2.6. Upon receipt and verification of the claim, Canon will post the album to the person named on the claim form at the address specified on the claim form. No other arrangements will be entered into.
- 2.7. Canon will endeavour to post items within 28 days of receipt of claim. However, Canon will not be liable for any items not issued within this time.
- 2.8. In order to have a chance of receiving the album before Christmas 2008 the claimant must ensure their claim is received **before** 27 November 2008. Canon will then endeavour to process the claim in time but will not be held responsible for any delays with the postage system
- 2.9. Only one (1) claim may be made per product purchased.
- 2.10. Photocopies of the original receipt(s) must be sent to Canon with the claim form.
- 2.11. Proof of posting is not proof of receipt. Participants are advised to use secure method of delivery.
- 2.12. No responsibility will be accepted for claims lost, delayed or damaged in the post or for those claims not received by the closing date specified in Clause 2.4.
- 2.13. Claims will be disqualified if incomplete or illegible. It is the participant’s responsibility to ensure that sufficient details are provided for claims to be processed.
